DOCUMENTS REQUIRED FOR PERMANENT VISA FOR FAMILY REUNION

- VISA APPLICATION FORM FILLED ONLINE WITH PASSPORT SIZED PICTURE ON IT.
- ORIGINAL VALID PASSPORT.
- COPY OF PASSPORT ON A4 SIZE PAPER. (PLEASE DO NOT CUT DOWN TO SIZE)
- ORIGINAL BIRTH CERTIFICATE (IF NOT MARRIED) OR ORIGINAL MARRIAGE CERTIFICATE (IF MARRIED) ATTESTED BY MINISTRY OF FOREIGN AFFAIRS AND (1) COPY OF EACH.
- ORIGINAL FRC (FAMILY REGISTRATION CERTIFICATE) ATTESTED BY MINISTRY OF FOREIGN AFFAIRS.
- NOTARIZED COPY OF ID CARD OF THE FAMILY MEMBER WHO LIVES IN BRAZIL.
- AFFIDAVIT (TERMO DE RESPONSABILIDADE E MANUTENÇÃO), WRITTEN BY THE FAMILY MEMBER WHO LIVES IN BRAZIL AND NOTARIZED BY NOTARY PUBLIC IN BRAZIL.
- MARRIAGE CERTIFICATE IF THE MARRIAGE WAS CELEBRATED IN BRAZIL & (1) COPY. THE DOCUMENT MUST BE ATTESTED IN BRAZIL. MARRIAGE CELEBRATED IN PAKISTAN MUST BE REGISTERED WITH THE EMBASSY.
- OTHER FAMILY MEMBERS MUST PROVIDE PROOF OF THE RELATIONSHIP (BIRTH CERTIFICATE, ETC).
- AFFIDAVIT PROVING OF BEING SINGLE ATTESTED BY THE MINISTRY OF FOREIGN AFFAIRS.
- IF DIVORCED, DIVORCED DEED ATTESTED BY THE MINISTRY OF FOREIGN AFFAIRS.
- BANK STATEMENT OF LAST 6 MONTHS ALONG WITH BANK LETTER.
- COLORED COPY OF PASSPORT OF BRAZILIAN MEMBER ON A4-SIZE PAPER
- MINORS UNDER 18 YEARS OF AGE ARE REQUIRED A NOTARIZED LETTER OF CONSENT BY THE PARENT NOT TRAVELING WITH THE MINOR, OR BY BOTH PARENTS IF THE MINOR IS TRAVELING ALONE.

Note: Please make sure you bring **ALL** the documents with you.
